Motivation and Goals

- Simulate "real-world" software development
 - contribute to a large, existing project, whose lifecycle does not coincide with the typical student project
 - collaborate both with other students (with different experience and background) and, possibly, with other active developers
 - learn to manage a work schedule where regular progress and communication is as important as the final deliverable
 - learn new tools and languages
 - work with people living in different cities and time zones

UCOSP and Other Similar Efforts

- Upper-level undergraduate students
 - other courses involve masters students or mixed undergrad/ graduate groups
- "Real" open-source projects
 - simplifies IP issues, increases visibility
- Within Canada
 - other courses focus on multi-country and multi-cultural teams
- The sprint is a key factor in project success, unique to UCOSP
- Theory/Practice mix: UCOSP is fundamentally project based
 - most other courses involve lectures and/or seminars (with associated course materials)
- Tools are similar
 - GIT, Eclipse, Jazz, blogs

Organization


- Project groups of 5-8 students from 2-4 different Canadian universities
- 1 mentor/client (academic faculty/industrial partner)
- 1 faculty member (at each student's home university) responsible for assigning a grade for the students in this university
- An open-source system for extension or enhancement
- Collaboration, communication and development tools dictated by the system
- Agile process (frequent deliverables, pair programming)
- Code Sprint (essential for getting started)
